

## AKC Field Trial Judges Seminar – October 16, 2021 – Canyon RV Park, Anaheim, CA

The Dachshund Club of Santa Ana Valley is pleased to announce a confirmed date for an AKC Field Trial Judges Seminar on Saturday, October 16, 2021 at Canyon RV Park, 24001 Santa Ana Canyon Road, Anaheim, CA 92808. The seminar will be in the clubhouse next to the swimming pool. It will start at 8:30 am sharp and conclude approximately 4:30 pm with a break for lunch.

The seminar is for anyone interested in judging dachshund or basset field trials, or just learning more about the judging process. Class material will be available at the seminar and there is a written test at the end for anyone wanting to be approved by the AKC to judge dachshund and basset field trials.

Registration will be on a first-come, first-paid basis. We hope to be able to accommodate everyone who would like to attend. If it turns out we have to limit attendance due to available space, priority will be given to anyone who has not attended a seminar before.

The seminar cost is \$25.00 per person and includes all AKC materials. Please add an additional \$14.00 per person if you want to include a pre-ordered boxed lunch. You are also welcome to bring your own lunch. Be aware the lunch break will not be long enough to leave the park and go to a restaurant so come prepared. DCSAV will have complimentary coffee & pastries in the morning and bottled water with lunch.

Canyon RV Park has graciously agreed to waive the \$5.00 per car entry fee for our attendees. When entering the park, please tell the gate attendant or check in at the office and advise them you are attending the Dachshund Club of Santa Ana Valley seminar at the clubhouse. Parking at the clubhouse is very limited but there is overflow parking within walking distance.
